RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to participate in the 2006 DRIVE on Saturday, June 24, 2006, the undersigned:

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT to sue the Palo Alto Lions Host Club, the Palo Alto Lions Charities Inc, the Palo Alto Concours Inc, Stanford University, Stanford Shopping Center including all its tenants, their officers, members, volunteers and all car owners, promoters, sponsors, advertisers used to conduct the event, and each of them, their officers and employees, referred to as RELEASEES, from all liability to the Undersigned, his personal representatives, or damage, and any claim or demands therefor, on account of injury to the person or property or resulting in the death of the undersigned whether caused by the negligence of Releasees, or otherwise while the undersigned is participating in the DRIVE.

2. HEREBY AGREES TO INDEMNIFY, DEFEND AND HOLD HARMLESS the RELEASEES: and each of them from loss, liability, damages, attorney's fees or costs they may incur due to the participating of the undersigned in the DRIVE.

3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to negligence of RELEASEES or otherwise while officiating or observing, working or for any purpose involved with or regarding the DRIVE.

THE DRIVE is not a speed contest nor is it a competitive event, however, driving on public roads may be dangerous and to that end, the UNDERSIGNED RELEASOR expressly assumes all risks. EACH OF THE UNDERSIGNED expressly acknowledges and agrees that participating in the DRIVE may be dangerous and may involve a risk of injury and/or death and/or property damage. EACH OF THE UNDERSIGNED further expressly agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State of California in which the event will be conducted and that if any portion of it is held invalid, the balance shall, notwithstanding, continue in full legal force.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS RELEASE AND WAIVER OF ALL LIABILITY AND INDEMNITY AGREEMENT, and agrees that the braking system of the entered car is in good, safe mechanical order and further agrees that no oral representation, statements or inducements apart from the foregoing written agreement have been made.
